MEMBERS WORLDWIDE PERSONAL LIABILITY/PERSONAL ACCIDENT INSURANCE

PERSONAL LIABILITY 1) **Unlimited** in respect of any one occurrence for bodily injury in respect of UK Road Traffic Act Liability arising out of the use of a golf buggy hired from the Club whilst playing golf on a recognised golf course.

2) **Increased up to £10,000,000** in respect of legal liability for bodily injury they cause to a third party or damage they cause to third party property while they are playing golf.

ACCIDENTAL DAMAGE Irrespective of legal liability insurers **have increased the limit to £20,000** to make good damage to third party property.

PERSONAL ACCIDENT Up to **£15,000** in respect of Death, Loss of Limb(s) or Eye(s) or Permanent Total Disablement.

EMERGENCY DENTAL TREATMENT – Reimbursement of emergency dental treatment costs resulting from an accident whilst playing golf up to **£300**

SUMMARY OF BENEFITS

PERSONAL LIABILITY 1) **Unlimited** in respect of any one occurrence for bodily injury in respect of UK Road Traffic Act Liability arising out of the use of a golf buggy hired from the Club whilst playing on your golf course.

2) Up to **£10,000,000** in respect of legal liability for bodily injury they cause to a third party or damage they cause to third party property while playing at your Club.

ACCIDENTAL DAMAGE Irrespective of legal liability insurers have **increased the limit to £20,000** to make good damage to third party property.

The premium is dependent on the number of /visitors/ that played at your Club during the previous 12 month period as follows:

If your Club has more than 10,000 visitors the premium would be: 7.5p per round

Between 5,000 and 9,999 :10p per round and if your club has less than 5,000 visitors : 20p per round

Premium is payable to Golfguard Ltd either as an upfront payment or quarterly in arrears on a simple declaration basis

All premiums quoted are subject to receipt of satisfactory claims history details being provided by the Club.
