MEMBERS WORLDWIDE PERSONAL LIABILITY/PERSONAL ACCIDENT INSURANCE

PERSONAL LIABILITY 1) **Unlimited** in respect of any one occurrence for bodily injury in respect of UK Road Traffic Act Liability arising out of the use of a golf buggy

2) **Up to £10,000,000** in respect of legal liability for bodily injury caused to a third party or damage they cause to third party property

ACCIDENTAL DAMAGE Irrespective of legal liability up to **£20,000** to make good damage to third party property.

PERSONAL ACCIDENT **£15,000** in respect of Death, Loss of Limb(s) or Eye(s) or Permanent Total Disablement if an accident occurs while playing golf or spectating at a recognised golf event.

EMERGENCY DENTAL TREATMENT – Reimbursement of emergency dental treatment costs resulting from an accident up to **£300**

SUMMARY OF BENEFITS

PERSONAL LIABILITY 1) **Unlimited** in respect of any one occurrence for bodily injury in respect of UK Road Traffic Act Liability arising out of the use of a golf buggy hired from the Club whilst playing on your golf course.

2) **£10,000,000** in respect of legal liability for bodily injury they cause to a third party or damage they cause to third party property while playing at your Club.

ACCIDENTAL DAMAGE Irrespective of legal liability insurers to **£20,000** to make good damage to third party property.

The premium is dependent on the number of /visitors/ that played at your Club during the previous 12 month period as follows:

If your Club has more than 10,000 visitors the premium would be: 8p per round

Between 5,000 and 9,999 : 11p per round or if your club has less than 5,000 visitors : 21p per round
